PATIENT INSTRUCTIONS PRIOR TO PAIN TREATMENT

- 1. Please arrive for your appointment at your scheduled arrival time.
- 2. Please <u>arrange a driver to bring and stay for appointment</u> as well as assist you at home after your treatment. IF YOU TAKE BUS / CAB TO APPT YOU MUST HAVE FRIEND / FAMILY COME WITH YOU!
- 3. We cannot recommend driving an automobile or operating any type of equipment including household appliances for the afternoon and evening after treatment.
- 4. <u>Do not eat or drink</u> anything <u>6 hours</u> prior to your appointment, **this includes chewing gum or mints**! Please take all of your usual medications with a **SIP** of water (unless specifically instructed otherwise)
- 5. <u>NOTE:</u> If you are taking a blood thinner (Coumadin, Warfarin, Plavix, Heparin, Lovenox, Fragmin, Orgaran, Aggrastat, Tyclid) or any injectable blood thinner, please notify our office prior to your procedure for special instructions.

MEDICATIONS <u>NOT</u> TO TAKE BEFORE APPOINTMENT INCLUDE: PRESCRIPTION BLOOD THINNER - MUST BE OFF FOR ONE WEEK (7-10 DAYS) ASPRIN - MUST BE OFF FOR ONE WEEK BABY ASPRIN OR 80MG ASPRIN - MUST BE OFF THAT MORNING! ANY DIABETIC MEDICENE – MUST BE OFF OF THAT MORNING! CAN TAKE AFTER APPT!

- 6. You will receive "relaxation medication" prior to your treatment to make your procedure more comfortable.
- 7. The treatment takes about 15 30 minutes, with an average observation time of about 45 minutes. Your total stay may be up to 2-3 hours.
- 8. It will usually take at least several days before you feel any improvement from your injection. You should expect some discomfort from the injection for the first 48 hours (or longer).
